_____ Self Travel – Band assumes travel, arrangements, and transportation expenses.

_____ Travel of 6 passengers in a purchaser-provided 12 passenger van and gear trailer, including but not limited to all drivers, fuel, maintenance, cleaning and insurance coverages. Van must be reliable, clean and 100% completely functional. Model year must be within most recent 5 years with less than 25,000 miles, or better. Van travel will require 3-star hotel room or better, for each passenger, nightly.

_____ Travel of 6 to 10 passengers to be in a purchaser-provided entertainment tour coach with up to 12 bunks and adequate gear trailer applicable, including but not limited to all drivers, fuel, maintenance, cleaning and insurance coverages. Tour coach must be reliable, clean and 100% completely functional. Model year must be within most recent 5 years with less than 300,000 miles or better. Bus travel will require seven 3-star hotel rooms or better; (1 required for driver, and 6 rooms for passengers).

_____ Flights – Minimum of (6) Flights required, round-trip, 'typically' originating from Dayton, Ohio (please double check departure/return city prior to booking, one or more artist/members may have prior engagement). Purchaser-provided flights must be on commercial airlines (preferably Southwest Airlines). No Non-commercial airlines accepted unless discussed and agreed for special circumstances. Fly Dates must include Purchaser-provided BACKLINE GEAR as listed on www.NashvilleLegendsLive.com/Production . Air travel will require 6 rooms at 3-star hotel or better, nightly.

Notes:

- Written agreement required, guaranteeing reserved performance date(s). Written agreement required on or before 30 days prior to first performance date noted herein.
- Non-refundable deposit of 50% of flat/gross rate or 50% of guaranteed minimum NBOR required on or before 30 days prior to performance date in order to secure booking.
- Purchaser to provide all necessary professional-level staging, sound, stage lights, crew, backline, safety and hospitality requirements for performers show and noted details in attached rider.
- Full payment will be required for cancellations within 48 hours of performance start date and time.
- Outdoor shows require contingency plan for inclement weather; please advise of stage roofing, wind walls, and Plan B contingency. ARTIST TO BE PAID RAIN OR SHINE.
- Net box office receipts (NBOR) shall consist of not only hard copy, in-person and online ticketed box office

sales, but all NBOR shall also include any and all Presenter-produced distribution and/or transmission of the Performance, including but not limited to Live Streaming, On Demand, Pay-Per-View sales and receipts, as well as any additional known and unknown forms including but not limited to audio/video/alternate media broadcast and performance reproduction sales and receipts as well.

- Purchaser shall assume all music licensing/publishing clearance responsibility and expense, for any and all Live Performances, Streaming, On Demand, Pay-Per-View distribution sales, as well as any additional known and unknown forms of transmission including but not limited to audio/video/alternate media broadcast and performance reproductions.
- With no purchaser-produced Live Streaming, On Demand, Pay-Per-View distribution sales, as well as any additional known and unknown forms of transmission including but not limited to audio/video/alternate media broadcast and performance reproductions, Purchaser shall make every effort to prevent any recording, distribution and/or transmission of the Performance without the written permission of Performer or Manager.
- Purchaser shall be entitled to use the names, likenesses, and other promotional materials provided by Performer or Manager for the purpose of promoting the Performance and attracting attendees.
- Purchaser shall provide COI listing members and crew of Nashville Legends Live! as additionally insured.
- Purchaser and Performer shall be excused from their obligations hereunder in the event of proven sickness, accident, riot, strike, epidemic, act of God or any other legitimate condition or occurrence beyond their respective control.
